#### **PROGRAM OF STUDY**

#### • Ombre Powder Brows & Hybrid Course Description:

Ombre Powder Brows is a form of permanent cosmetic brow technique that does not mimic hairlike strokes of natural brow hair. This form of technique requires complete shading of the eyebrow, with the head of the brow being the lightest and gradually darker towards the tail of the brow. Hybrid technique is the combination of hair strokes in the front of the brow and ombre towards the tail of the brow. Students learn everything from theory, techniques, brow mapping, marketing, and more to create this brow for clients in the most sanitary environment.

Day 1- Students will receive materials to begin learning theory and practicing in class on latex skin with instructor's guidance. Students must also practice at home after class to ensure students are prepared for hands-on training on the second day. Students will also watch the instructor's pre-recorded video of a LIVE model from start to finish. This video will help students to understand the procedure on a step by step basis to better prepare students for hands on Live model day. Practice with high quality 4k videos.

Day 2- Live model day. Practice makes improvements and working on models is the initial step into this profound profession. Students apply everything learned during the previous day and work alongside the instructor on a model.

### • Prerequisites Courses & Other Requirements for Admission to Program:

- 1. 21 years or older
- 2. OSHA approved Bloodborne Pathogen Certificate

3. Preferably one year experience in permanent makeup. All skill levels are accepted. Program Objectives: The objective of this course is to teach students the basis of Ombre Powder Brows using correct technique and depth. Course Calendar/Frequency: This course is generally offered over a two day period twice a month.

### • Program Objectives:

The objective of this course is to teach students the basis of Ombre Powder Brows and intro to Hybrid Brows using correct technique and depth. The student will learn to become proficient at Ombre Brows and an introduction to Hybrid Brows techniques. Course Calendar/Frequency: This course is generally offered over a two day period.

# • Refund / Cancellation Policy

A deposit or full tuition payment via cash, cashiers check, Visa, MasterCard, or Discover (NO PERSONAL CHECKS) will reserve a space in class. Students will receive a full refund of deposit or tuition if notice of intent to cancel is received within 72 hours after receipt of initial payment. If they attempt to cancel a class after 72 hours from payment there is a \$500 non-refundable fee. Deposit is deducted from tuition and balance of tuition is due on or before the start of class unless payment arrangements have been made and a promissory note has been signed before a notary public and returned. Deposit, nor tuition, are refundable if a student cancels after 72 hours of receipt of payment or if a student fails to show up for class. However, if there is a proven

emergency, we will offer the student the next available opening dates for two classes in which they can participate at no additional charge. Students must clear their schedule and pick from one of the two classes offered or they forfeit their deposit and/or tuition. Students must read, understand, and agree to their rights and responsibilities, and acknowledge that the cancellation and refund policies have been clearly explained.

The student's last date of attendance is used to determine the refund due. Refund provisions apply only to complete withdrawal from the Academy. Should the student's enrollment be terminated or should the student withdraw for any reason, all refunds will be made according to the following refund schedule:

- During the first 5% of the class, a refund of 95% of the class's tuition, and fees;
- More than 5% of the class up to 10% of the class, a refund of 90% of the class's tuition, and fees;
- More than 10% of the class up to 20% of the class, a refund of 80% of the class's tuition, and fees;
- More than 20% of the class up to 25% of the class, a refund of 75% of the class's tuition, and fees;
- More than 25% of the class up to 30% of the class, a refund of 70% of the class's tuition, and fees;
- More than 30% of the class up to 40% of the class, a refund of 60% of the class's tuition, and fees;
- More than 40% of the class up to 50% of the class, a refund of 50% of the class's tuition, and fees;
- More than 50% of the class up to 60% of the class, a refund of 40% of the class's tuition, and fees;
- More than 60% of the class or thereafter, 100% tuition obligation, no refund available with all fees retained.

# • Withdrawal Procedure

The student may officially withdraw from school by notifying Touch of Brows in writing or in person. The withdrawal date will be the student's last date of attendance. The refund policies outlined above shall apply in the event that a student withdraws, is suspended or is terminated from school.

# • ACCREDITATION

Touch of Brows is not currently accredited by any recognized accrediting body of the U.S. Department of Education. Touch of Brows adheres to the governing licensing regulations and standards of the State of Illinois in which it holds classes.
